# 1. Welcome

Ian explained the current state of the club finances and stated the increase in coaching fees is relative to the increase in number of members. We are very grateful to Macbeth Insurance for their kind sponsorship of £1500 to help subsidies club kit and help cover ad-hoc costs throughout the year.

A question was raised by Karen Ford as to if the club pays insurance. As part being a Triathlon England affiliated club the club receives £15m public liability insurance.

## 9. Strategy and direction for forthcoming year

Ellie stated she plans to keep doing what we're doing unless anyone had any other ideas! We would like to increase the number of younger members as we do not currently have any members born in 2016, the Tristar Start age group. Ellie suggested a Bring a Friend session to increase awareness about the club. Ellie also stated that those running parkrun, if they select their club as Reading Rascals this helps with awareness.

Ellie also stated that she intends to carry on using SPOND app to manage membership, attendance and payments as the system has helped and streamlined Ellie's administration tasks. Please use SPOND to communicate with Ellie if necessary.

A question was raised by Mr Evans as to whether we had ever though about an additional training session in the week after school, in particular a regular swim session. Ellie stated that this has been discussed previously, however finding pool time is incredibly challenging. Ellie to discuss further with committee and coaches at their next planning meeting on Wednesday 13 March and to revert with update.

Ellie to update and circulate publicity flyer about the club which she would appreciate members to circulate within their networks – school friends, other clubs, social media etc.

#### 10. Any other Business

Ellie stated that she had been contacted by Macbeth Insurance Brokers alerting us of the <u>Allianz Sports Fund</u> which we are eligible to apply for as we have a connection to an insurance broker, we are an affiliated club to a national governing body and we have a bank account registered in the club name. Ellie stated there are grants ranging from £500 - £3,000 available to apply for before Friday 8 March. The grant can be used to help cover of venue hire, equipment, club league affiliation fees, travel and kit. Ellie to submit an application on behalf of the club.
